**A F F I D A V I T**

Comes now the affiant, of lawful age, in support of a probable cause finding for the detention of the defendant or the issuance of an arrest warrant, states as follows:

1. On May 9, 2024, J.M. and C.M. reported their son, C.T.M. (xx/xx/2006) had an ongoing sexual relationship with Cassidy Alexander. Cassidy Alexander and C.T.M. are not married, and in fact Alexander's husband was deployed during this time frame. J.M. and C.M. had become suspicious based on C.T.M. sneaking over to Alexander's in the night and lying about why. J.M. and C.M. confronted C.T.M. about his relationship with Alexander and he admitted they were having a sexual relationship, however, he said at the time that it didn't start until he was 18 years old.

2. However, C.T.M had previously disclosed to his cousin, S.S. the sexual relationship between he and Alexander, and that it had started in July of 2023, when the victim was 17. C.T.M. said that met Cassidy Alexander when he was in 8<sup>th</sup> grade and in cross country at Lexington Trails Middle School in DeSoto. She was his cross-country coach and a paraprofessional at the school he attended. In high school, C.T.M. began the babysit Cassidy Alexander's children. At that time Alexander was an assistant high school tennis coach at DeSoto High School, where C.T.M. was enrolled as a student.

3. Law enforcement officers spoke to both Cassidy Alexander and C.T.M. regarding their relationship. C.T.M. said things got flirty in the summer of 2023, he was 17 years old, and she was 26 years old. C.T.M. said the two began having sex in July 2023. He said they had sex at least ten to fifteen times between July 2023 and March 2024 (when he turned 18 years old). C.T.M. said the sexual encounters were always at Cassidy Alexander's house, located in Johnson County, Kansas.

4. Cassidy Alexander said during the summer of 2023 the relationship changed from friendly to sexual. She identified the first time they had sex as around the time of a vacation she took July 25, 2023. C.T.M. left the country for study abroad between August 2023 and January 2024, but when he returned in January 2024, Alexander said they "picked up where they left off" meaning they would hang out, talk and have sex. She said they had sex eight to ten times after C.T.M. returned from study abroad.

5. The cell phones of C.T.M. and Cassidy Alexander were searched, and law enforcement found numerous photos hugging, kissing and in sexual situations, as well as messages expressing their love to one another.

6. The above information was provided from the reports of the Johnson County Sheriff's Office.
